An authorised officer of the City of Darebin may revoke a permit and impound any offending items if the item is placed on Council Land without a permit or when directed to remove by an authorised officer

The City of Darebin must be listed or included in the insured territory or geographical scope on the applicant's public liability insurance. The applicant agrees to indemnify and keep the City of Darebin indemnified against any and all actions arising out of or in relation to the said agreement.

The permit holder must submit a Skip Bin Notification Placement Form at least 24 hours prior to any placements.
