- A copy of your current public liability insurance with a minimum of \$10 million dollars including the City of Darebin as an interested party.

General Requirements

Under the provisions of the City of Darebin Local Law number 1/2015, a business is required to obtain a permit to place any item on Council footpaths. Council provides footpath permits to traders to enable them to display items on the footpath while at the same time ensuring the safety of pedestrians. Council must approve the location of any items prior to placement.

Approved items are to be placed in accordance with Council's Footpath Trading Policy 2015. Items are only permitted on the footpath outside the applicant's property and are not to be placed on or affixed to vehicles, or to items which are the property of a public authority such as electricity, tramway and Council poles.

A Footpath Trading Permit is subject to the conditions of issue in accordance with the Footpath Trading Policy. An authorised officer of the City of Darebin may revoke a permit and impound any offending items if the item is placed on Council Land without a permit or when directed to remove by an authorised officer.

Privacy statement

The collection and handling of personal information is in accordance with Council's Privacy Policy which is displayed on Council's website and available for inspection at, or collection from, Council's customer service centre/s.

Footpath trading activities must:

- Only be placed in the Trading Zone of the footpath and where applicable.
- Positively contribute to the amenity of the area.
- Not impact detrimentally on people or property in the neighbourhood because of unreasonable noise caused by patrons, amplified music, litter and a lack of cleanliness of the area.
- Align to the boundary adjacent to the Kerbside Zone to maximise the amount of space for pedestrian movement.
- Not be of a permanent nature or of a fixed installation (with the exception of approved café screens or permission granted by Council).
- Be of a high quality design, construction and finish that Council considers attractive and will complement the character of the streetscape and contributes to the visual and urban amenity of the area.
- Be of sturdy and safe construction.
- Not include sharp, protruding or moving parts.
- Not be fixed to any Council or other infrastructure.
- Not cause damage to the footpath.
- Not be illuminated, reflective, flashing or animated in any way or can be mistaken for a traffic sign.
- Not obstruct a driver line of sight, distract or confuse a driver.
- Be maintained to an appropriate standard at all times as determined by Council.
- Only be placed on the footpath during normal trading hours of the business or permission granted by Council

DECLARATION

The applicant must sign this indemnity on behalf of the business, organisation or group.

I certify that I am the applicant or authorised by the applicant/owner to bind the applicant/owner by signing this form. I am fully aware of the Darebin City Council policy and conditions for displays on footways that apply to the permit sought by me. I understand that Council may require further information from me in support of my application or that Council may refuse my application or grant a permit with conditions, which I agree to abide by.
