

IMPORTANT INFORMATION

If you were not the driver, owner or person in control or possession of the vehicle / trailer, the subject of the infringement notice, you may make a statement to the following effect -

- **Nominating Another Driver**

If you were not the driver at the time of the offence complete **PARTS A, B, C, E, & F, OR**

- **Sold Vehicle**

If you had sold the vehicle at the time of the offence, complete **PARTS A, B, C, & F, OR**

- **Unknown Driver**

If you cannot reasonably determine who the driver was at the time of the offence complete **PARTS A, D, E & F, OR**

- **Stolen Vehicle or Number Plates**

If the vehicle or number plates displayed on the vehicle were stolen complete **PARTS A, D, E & F, OR**

- **Rejecting a Nomination**

If you have been nominated incorrectly complete **PARTS A, D, E, & F.**

If the information provided in your statement is not sufficient to identify and locate the nominated person or if the person nominated in your statement rejects the nomination after being issued with an infringement notice, the liability for this offence may remain with you.

It is an offence under the *Road Safety Act 1986* to knowingly provide false or misleading information in your Statement- the maximum penalty being \$6,600.
