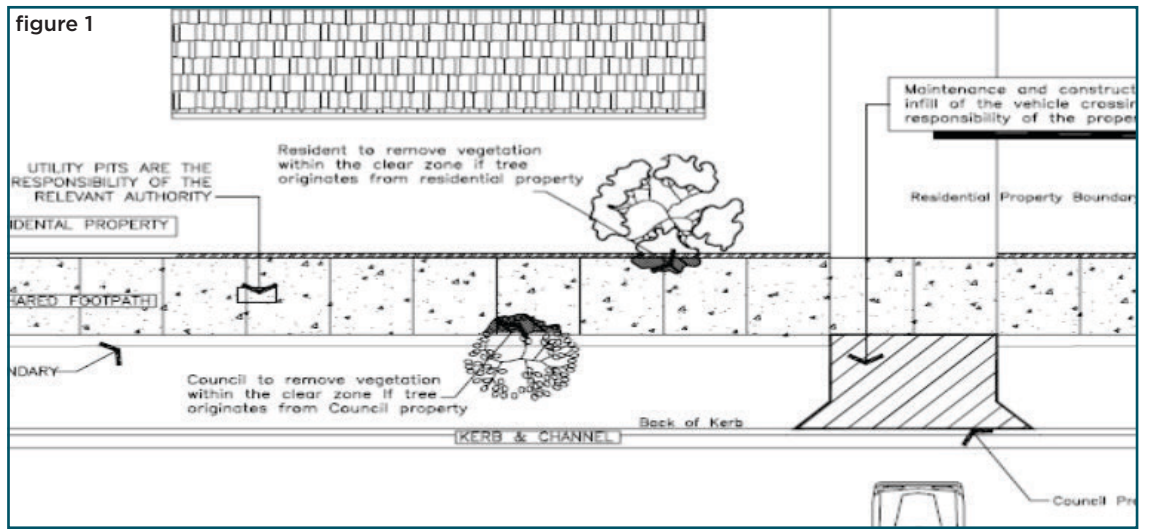

Vehicle Crossing Conditions of Permit

A Private Crossing Permit does not represent the approval of other departments of the Darebin City Council or other statutory Authorities. Such approvals may be required and may be assessed on different criteria to that adopted for the approval of this Private Crossing Permit. A Vehicle Crossing Application is approved and permission is granted to construct the crossing on a date in conformity with the Council specification.

If the crossing cannot be constructed on the specified date, the Council must be notified otherwise it may be necessary to obtain a new permit. In their own interests, owners of the property having a crossing constructed by a contractor are advised to obtain in writing that the crossing will be constructed to the required Council specification. Property Owner will be held responsible for the works.

Note:

Vehicle Crossing Permits are required to be obtained prior to the commencement of works. All street features and services which may be affected as a result of the location of the crossing (pole, trees, pit and bus stop etc.) are the sole responsibility of the applicant to arrange at their own expense prior to commencement of works. No crossings are permitted within 9 metres of intersecting streets or within 1 metre of naturestrip trees, street signs or power poles.

All crossings are to be inspected by the responsible Council representative prior to pouring of concrete to ensure compliance with Council's standard Vehicle Crossing Specifications. Council has the right to reject any works not in compliance and direct the appropriate alterations. At all times it is the applicant's responsibility to ensure the site is safe. Any additional works required to be carried out by Council will result in the applicant being charged for these costs.
