7 Darebin Community Awards – Disability Category

Purpose:

Darebin Council holds annual Community Awards to recognise our community members.

We are considering adding a disability category and would like to seek feedback.

- What can Council do to make sure that a disability award category changes attitudes and raises awareness about disability?"

Summary of conversation:

- Two DDAC members supported the award category, especially for businesses and organisations. Members highlighted that there are significant gaps in disability access and inclusion, and introducing this award would be a good way to award effort and encourage businesses to be more accessible.
- One DDAC member did not support the award category because it may be seen to segregate disabled people from the rest of the community.
- DDAC members advised that other groups (e.g. LGBTIQA*) should also have dedicated award categories.

ACTIONS:

• Given that only carers/service providers were able to attend the meeting, project officers will follow up with the Access and Inclusion team to ensure that people with disability are included in the conversation.

8 LGBTIQA* Action Plan

Purpose:

Darebin Council is currently developing our LGBTIQA* Action Plan.

We would like feedback on the action plan from the DDAC.

Summary of presentation:

• Martti gave a presentation about Council's work on LGBTIQA+ Inclusion and the intersection between LGBTIQA+ and disability.

Questions to DDAC:

• How can we make sure Darebin's work on LGBTIQA+ inclusion is disability affirming?

DDAC provided the following feedback:

- People disability who are LGBTIQA* must be involved in this process of developing the plan.
- Council needs to understand the positive and negative experiences of LGBTIQA* people with disability and hear their voices.
- There is a growing number of young people who are trans and gender diverse. It is important to involve their voices in this work.
- DDAC members highlighted for the importance of accessible communication.
